



**LIMITED LIABILITY COMPANIES ACT 1996**  
**LIMITED LIABILITY COMPANIES (FEES AND DUTIES)**  
**ORDER 2008**

*Laid before Tynwald 11<sup>th</sup> March 2008*

*Coming into operation on 6<sup>th</sup> April 2008*

In exercise of the powers conferred on the Financial Supervision Commission by section 50 of the Limited Liability Companies Act 1996 <sup>(a)</sup>, and of all other enabling powers, with the concurrence of the Treasury the following Order is hereby made:-

**1. Citation and Commencement**

(1) This Order may be cited as the Limited Liability Companies (Fees and Duties) Order 2008, and shall come into operation on 6<sup>th</sup> April 2008.

(2) In this Order –

“the Act” means the Liability Companies Act 1996

“company document” means a document held by the Financial Supervision Commission under the Limited Liability Companies Act 1996.

“online” means remote access to company documents held on the Financial Supervision Commission, Companies Registry Public Viewing System by means of the Internet;

**2. Fees and duties in respect of Limited Liability Companies**

The fees set out in the Schedule shall be taken in the Companies Registry in respect of the matters specified.

**3. Revocation**

The Limited Liability Companies (Fees and Duties) Order 2005 <sup>(b)</sup> and the Limited Liability Companies (Fees and Duties) (Amendment) Order 2005 <sup>(c)</sup> are revoked.
