



PARTNERSHIP ACT 1909

PARTNERSHIP (FEES) RULES 2008

Approved by Tynwald 12th March 2008

Coming into operation 6th April 2008

In exercise of the powers conferred on the Financial Supervision Commission by section 59(1) of the Partnership Act 1909^(a), and of all other enabling powers, with the concurrence of the Treasury the following Rules are hereby made:

1. Citation, commencement and interpretation

(1) These Rules may be cited as the Partnership (Fees) Rules 2008 and subject to section 59(2)(b) of the Act, these Rules shall come into operation on 6th April 2008.

(2) In these Rules –

“the Act” means the Partnership Act 1909.

“documents” means documents filed in the Companies Registry in terms of the Partnership Act 1909.

“online” means remote access to the Isle of Man Companies Registry Public Viewing System by means of the Internet.

2. Fees in respect of Limited Partnerships

The fees set out in the Schedule shall be paid to the Financial Supervision Commission in respect of the matters specified.

3. Revocation

The Partnership (Fees) Rules 2005^(b) are revoked.
