## Condition

- (1) The Auditor must be qualified for appointment as an auditor under sections 14 to 14H of the Companies Act 1982.
- (2) The registration is restricted to the audit of Eros Media World PLC (Isle of Man Company Number: 007466V).
- (3) The appointment of any additional Responsible Individuals for the audit of Eros Media World PLC must be notified to the Authority not less than 20 business days in advance of the appointment.
- (4) The Auditor must ensure the Institute of Chartered Accountants in England and Wales or Financial Reporting Council, as appropriate, are able to carry out their monitoring and oversight functions in relation to the registration without impediment, lawful or otherwise, and the Auditor agrees to the cost of such monitoring and oversight functions.
- (5) The Auditor must undertake suitable checks with a Recognised Auditor<sup>1</sup>, advocate or law firm<sup>2</sup> with a place of business in the Isle of Man to satisfy itself that each audit of Eros Media World PLC is compliant with Isle of Man company law, and the Auditor must provide evidence to the Authority within one month of each audit being completed that such checks have been undertaken along with an explanation as to the nature and extent of such checks.
- (6) The Auditor must provide evidence to the Authority annually that it has the necessary registrations with the PCAOB in the United States to enable it to audit Eros Media World PLC.
